4. The **Sealed and signed (mentioned GST number also) quotation** shall be sent to IIIT, Sri City, Chittoor, 630 Gnan Marg, Sri City, Satyavedu Mandal, Chittoor District, Andhra Pradesh – 517646 only.
5. Last date and time of submission of quotation would be : 10 AM on 07.12.2018.
6. Validity: Minimum validity of the quotation must be 30 days from the date of opening of the quotation/tenders.
7. As the firm is required to deliver the items at IIIT Sri City, Chittoor with minimum Three year guarantee/warranty, so the rates must be quoted as F.O.R. destination i.e., IIIT, Sri City, Chittoor, and the rates must include the charges for packing, forwarding, insurance, freight, commissioning, demonstration, transportation charges etc., if any.
8. The price of items may be quoted in Indian rupees.
9. All the firms may invariably mention their CST/ST/LST/PAN numbers on quotation/tender failing which quotations may not be considered valid. Further, this institution does not issue any Concessional form, so the CST/ST/GST applicable as per actual rates must be mentioned in the offer. In case CST/ST/GST is not mentioned, the rates shall be treated as inclusive of all taxes.
10. 100% payment shall be made in full within 30 days after receipt of material in good condition. Payment will be initiated only after the receipt of a certificate/report about successful demonstration/installation from the department/officer concerned.
