2. Minimum Eligibility Criteria:

First Class Master's Degree (PhD Preferable) in the relevant disciplines from a CFTI or an equally reputed national or overseas university along with minimum of 10 years of relevant industry experience.

Previous teaching experience in CFTI/Institution of National Importance or equally reputed institution is an advantage.

3. Salary & Benefits:

The remuneration shall be as per the norms of the institute. Eligible for TA & DA as per norms of the institute. Adjunct Faculty is not eligible for any other benefits.

4. Term of Appointment:

Initial appointment will be period of one Semester (For specific subjects) with possibility of further extensions.
