- 1. We are interested in the material available from Ready Stock / Within 0 weeks
- 2. The quotation may be submitted only if you are able to complete the supply and installation within the time limit.
- 3. Please indicate GST number on the application and attach a copy of GST certificate.
- 4. As the firm is required to deliver the items at IIIT Sri City, Chittoor with a minimum Three year guarantee/warranty, so the rates must be quoted as F.O.R. destination i.e., IIIT, Sri City, Chittoor, and the rates must include the charges for packing, forwarding, insurance, freight, commissioning, demonstration, transportation charges etc., if any.
- 5. The complete offer should be typed in the letterhead of the tenderer. The offer should be signed & stamped by the Company's authorized signatory.
- 6. Please write the detailed specifications as the product brochures.
- Rates quoted in the tender should be inclusive of GST, and should be valid for 90 days. Breakdown
  details of packing, forwarding, freight and insurance charges in percentages should be shown
  separately. The goods should be insured in our favor against all risks from Warehouse to
