I. TERMS OF APPOINTMENT:

The Recruitment Rules and Pay & Allowances of IIIT Sri City are benchmarked with CFTI (Centrally Funded Technical Institutions under Ministry of Education, Government of India) along with 7th CPC guidelines. The terms of employment and benefits are governed by the service conditions laid down by the Board of Governors of IIIT Sri City.

Important Information:

Higher starting pay (as Top-up Pay) will be offered to candidates possessing exceptional research and academic credentials.

In addition to pay & allowances equivalent to 7th CPC, faculty members are eligible for *additional allowances* as approved by the Board of Governors. Currently the institute offers higher HRA, LTA, medical insurance, etc.

A proposal is approved by the Board of Governors to offer annual *performance-based financial incentives* for performance above benchmark level in teaching, research and administration.

UG and PG degrees in the relevant or equivalent disciplines of CSE/ECE and PhD degree in a relevant or equivalent disciplines from leading recognized universities with consistently excellent academic records.

Essential: All new entrants shall have Ph.D. in relevant or equivalent discipline and shall have first class in their preceding Degrees.

Candidates who have earned their PhD /Post Doc experiences from reputed overseas universities or CFTIs such as IISc, top IITs, top NITs etc. with high potential for quality teaching and research are encouraged to apply.

Faculty members are expected have high level of competences to engage with students/learners through online mode for teaching, mentoring, assessments, etc.

However, hard copy of application along with documents should reach the undersigned before 15/07/2022 22/07/2022 (Please note that hard copy of the application along with all documents is compulsorily required).

The candidates are required to attach latest category certificate (SC/ST/OBC-NCL/EWS/PwD obtained from the competent authority. The OBC certificate as per GoI format obtained on or after 01-04-2022 is only valid.

Further Instructions:

- 1. Candidates working in Govt. Organizations either should get their application forwarded through proper channel or will require to submit a "No Objection Certificate" from their employers at the time of interview, if shortlisted.
- 2. Submission of application does not provide right to be called for interview. If a candidate is called for interview, he/she will not get any right for selection and appointment. There is no system or practice to send any written communication to candidates not called for interview or who are not selected after interview, indicating the reasons for rejections. Institute has the option to limit the number of candidates called for interview considering number of positions to be filled in, specialization requirement, subject discipline, etc.

- 3. Possession of essential qualification and experience does not guarantee candidate to be called for interview. Institute has authority to limit number of candidates to be called for interview based on qualification, experience, specialization requirement etc.
