- 3. The tender in SINGLE bid systems in sealed envelope shall be submitted in the office of Registrar in the prescribed format before the due date and time as mentioned in NIQ. No other mode of submission is acceptable.
- 4. Sealing and Marking of Bids:
 - The Techno-Commercial bid must be sealed in an envelope, duly super-scribed as "Techno-Commercial Bid, NIQ No.: ______, Submission Deadline: _____
- 5. Offer must be legible, clear and free from overwriting and cutting. Incomplete submissions are liable to be rejected.
- 6. All the specified works shall be completed within 15 days of award of work including sample approval.
- 7. Site Visit: Every bidder is expected to inspect the site/locations between Monday to Saturday from 10:00 Hrs to 16:00 Hrs except Sunday and Govt. holidays, to ascertain the exact requirement of the NIQ, at his own cost before quoting the rates.
- 8. IIIT Sri City reserves the right:
 - a. to accept or reject any or all quotations either in whole or in part or to invite revised price bids or to annul the bidding process
 - b. to postpone and/or extend the date of receipt/opening of quotation or to withdraw the same at any time before finalization without incurring any liability to the affected Tenderer / Bidder.
 - c. to omit/delete any item(s) of work from the schedule at the time of allotment or before the commencement of work without assigning any reason whatsoever.
 - d. to change the quantity or add the item or cancel the item/service required.
