- 1. The Bidder Company or firm should have an average Turnover of ₹10.00 Crore or above during 3 out of the last 5 Financial Years. (2017-18, 2018-19, 2019-20, 2020-21, 2021-22). The Bidder shall upload audited balance sheets of accounts for the last 3 out of 5 financial years 2017-18, 2018-19, 2019-20, 2020-21, 2021-22).
- 2. The Bidder shall upload copies of the GST Registration certificate and PAN Certificate. The bidder should have supplied at least one Single Purchase Order with 20 Quantities of Access Points or two purchase orders with a minimum of 10 quantities of Access Points or four or above purchase orders with a minimum of 5 Access Points to PSUs/Central or state governments/ Universities /CFTIs during any of the last five years (2017-18, 2018-19 &2019-20, 2020-21, 2021-22) or current year. Copies of purchase orders should be uploaded along with the Technical Bid.
- 3. The Bidder (s) shall have a valid Manufacturing License/ Authorised Dealership of their own for supply and maintenance facilities of their Products.
- 4. The OEM should have their sales/service center within a 350Km radius from IIIT Sri City Chittoor
- 5. The Authorised Dealers/Manufacturers of Networking Equipments having minimum manufacturing /Supplying experience of 3 years are eligible to participate.
- 6. The Bidder should not be banned/blacklisted by any government institution in previous years. Self-declaration by the bidder in this regard is to be enclosed with the bid. If it is found later that the information given is incorrect/false then the bid is liable to be rejected.

Experience Criteria:

In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through a reseller(s)} should have regularly, manufactured and supplied the same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for a number of years as indicated in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bids in support of having supplied some quantity during each of the years. In the case of bunch bids, the category of the primary product having the highest value should meet this criterion.





Document required from seller:

Experience Criteria, Past Performance, Bidder Turnover, Certificate (Requested in ATC), OEM Authorization Certificate, OEM Annual Turnover *In case any bidder is seeking exemption from Experience / Turnover Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer

Past Performance:

The Bidder or its OEM {themselves or through a reseller(s)} should have supplied the same or similar Category Products 20 quantity or more, in at least one of the last five years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one year) to be submitted along with bid in support of quantity supplied in the relevant year. In the case of bunch bids, the category related to the primary product having the highest bid value should meet this criterion.

Terms & Conditions:

- 1. Complete specification with manufacturer's name, address, GST No. and PAN No. should be mentioned while quoting. Literature/Pamphlets should also be enclosed wherever applicable.

- 4. Price quoted should be valid for a minimum period of 90 days from the date of opening of the quotation. As the firm is required to free deliver the items at IIIT Sri City, Chittoor with a minimum Five-year guarantee/warranty, the rates must be quoted as F.O.R. destination i.e., IIIT Sri City, Chittoor, 630, Gnan Marg, Sri City, Chittoor District, Andhra Pradesh, PIN 517 646, and the rates must include the charges for packing, forwarding, insurance, freight, commissioning, demonstration, transportation charges, etc., if any. Bid Specific Additional Terms and Conditions

1. Experience Certificate for the supply of the same to any Govt/ PSU/ any renowned

private organization along with Supply/ Purchase Order.

2. **OPTION CLAUSE:** The Purchaser reserves the right to increase or decrease the quantity to be ordered at the time of placement of the contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

3. Scope of supply (Bid price to include all cost components): Supply Installation Testing Commissioning of Goods and Training of staff and providing Statutory

Clearances required (if any).

4. IMPORTED PRODUCTS:

In the case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after-sales service support in India. The certificate to this effect should be submitted.

5. Bidder Turnover Criteria:

The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution/incorporation of the bidder is less than 3 years old, the average turnover in respect of the completed financial years after the date of the constitution shall be taken into account for this criteria.

6. Warranty & Maintenance contract:

The supplier shall warranty equipment and system components for a minimum

period of **05** years following satisfactory installation, Configuration, and commissioning. The defects, if any, during the guarantee/warranty period are to be rectified free of charge by arranging free replacement wherever necessary. All expenditure including government levies on account of the replacement is to be borne by the supplier/agent.

7. Installation, Configuration & Testing:

The installation shall be completed within a week from the date of intimation regarding the arrival of the equipment in the institute. The installed system shall be performance tested at our premises in accordance with the manufacturer's/supplier's recommendation/specifications. Tests shall demonstrate the proper operation of the instrument and all components.

8. All supplies are subject to inspection and approval before acceptance. Manufacturer warranty certificates and manufacturer/Government approved lab test certificates

shall be furnished along with the supply, wherever applicable.

9. Kindly furnish your PAN & GST Number etc. in your bid for our records.

10.ARBITRATION:

- a) Unless otherwise specified, in all cases of disputes which cannot be settled by mutual negotiations, the disputes or differences shall finally be settled and binding on both parties by arbitration in conformity with the rules of the Indian Arbitration Act, 1940. All disputes or differences whatsoever arising between the parties relating to the construction, meaning, and operation or effect of the general terms and conditions including the Purchase Order or the breach thereof shall be settled by Arbitration Act, 1940 and the award made in pursuance thereof shall be binding on the parties.
- b) Performance of the purchase order shall continue during arbitration and any subsequent proceedings.
- c) The Jurisdiction and Venue of arbitration shall be IIIT Sri City, Chittoor. The Arbitrator will be the Director, IIIT SriCity, or his nominee.
