- Validity: Minimum validity of the quotation must be 30 days from the date of opening of the quotation/tenders.
- The quantities of various items of sports goods given in the NIT are approximate. The quantities may vary at time of order. The Competent Authority of IIIT Sri City, Chittoor reserves the right to omit/delete any item(s) from the schedule at the time placing purchase order without assigning any reason whatsoever. Bidder will be paid for the authorized actual items supplied at the site duly verified by the concerned officials of IIIT Sri City, Chittoor.
- The quotation may be submitted only if you are able to supply the material within one week from the date of issue of Purchase Order. Exact delivery period will be mentioned in the Purchase Order.
- The materials are to be supplied on door delivery basis at Registrar Office, IIIT Sri City, Chittoor.
- The Railway Receipt/Public Way Bill/Consignment Note along with the relevant bill and challan in triplicate should be dispatched to Registrar Office, IIIT Sri City, and Chittoor immediately on completion of dispatch. If these documents do not reach the Registrar Office, IIIT Sri City, Chittoor in time all wharf age/demurrage incurred, if any, will be recoverable from the bidder.
- As the firm is required to deliver the items at Registrar Office, IIIT Sri City, Chittoor, so the rates must be quoted as F.O.R. destination i.e., IIIT Sri City, Chittoor, 630, Gnan Marg, Satyavedu mandal, Sri City, Chittoor Dt A.P-517646 and the rates must include the charges for packing, forwarding, insurance, freight, commissioning, demonstration, transportation charges etc., if any.
- The price of items may be quoted in Indian rupees.
- All the firms may invariably mention their CST/ST/LST/PAN numbers on quotation/tender failing which quotations may not be considered valid. Further, this institution does not issue any Concessional form, so the CST/ST/GST applicable as per actual rates must be mentioned in the offer. In case CST/ST/GST is not mentioned, the rates shall be treated as inclusive of all taxes.

Installation

- Bidder shall be responsible for installation / demonstration as applicable and for after sales service during the warranty and thereafter.
- Installation and demonstration to be arranged by the supplier free of cost and the same is to be done within 5 days of the arrival of the equipment at site.

Warranty / Support

- The items supplied shall carry a minimum of ONE year of comprehensive warranty from the date of acceptance of the equipment.
- The defects, if any, during the guarantee / warranty period are to be rectified free of charge by arranging free replacement wherever necessary. This includes cost, insurance, freight, custom duty, octroi, local taxes if any and should be borne by the beneficiary or his agent. A clear confirmation should be given for this item.

- **Indemnity** The vendor shall indemnify, protect and save IIIT Sri City, Chittoor against all claims, losses, costs, damages, expenses, action suits and other proceeding, resulting from infringement of any law pertaining to patent, trademarks, copyrights etc., or such other statutory infringements in respect of all the items supplied by him.
- Freight and Insurance: The items to be supplied will be insured by the vendor against all
 risks of loss or damage from the date of shipment till such time it is delivered at IIIT Sri City,
 Chittoor campus.
- 100% payment shall be made in full within 30 days after receipt of material in good condition. Payment will be initiated only after the receipt of a certificate/report about successful demonstration/installation from the department/officer concerned.
- Right of acceptance and rejection of any tender/quotation in part or full without assigning any reason are reserved with the institution authorities. The number of items to be purchased could be increased or decreased depending on the requirement of enduser.
