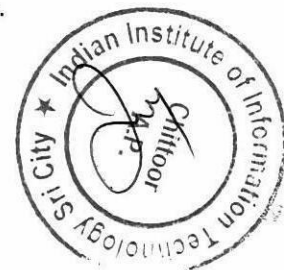

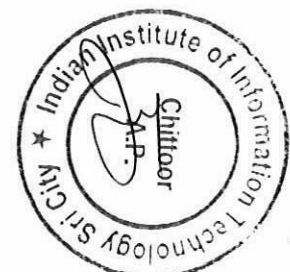
PART "A": NIQ DETAILS

1. **Tender Documents:** The interested parties may collect the tender documents from the Office of the Registrar and also download from web-site of IIIT Sri City – <https://www.iiits.ac.in/tenders/>
2. Bidders are advised to visit the website frequently to find any addendum/ Corrigendum issued or extension of due date for submission, etc. No separate intimation will be issued /advertised in this regard.
3. The tender in SINGLE bid systems in sealed envelope shall be submitted in the office of Registrar in the prescribed format before the due date and time as mentioned in NIQ. No other mode of submission is acceptable.
4. **Sealing and Marking of Bids:**
The Techno-Commercial bid must be sealed in an envelope, duly super-scribed as "Techno-Commercial Bid, NIQ No.: _____, Submission Deadline: _____".
5. Offer must be legible, clear and free from overwriting and cutting. Incomplete submissions are liable to be rejected.
6. All the specified works shall be completed **within 15days** of award of work including sample approval.
7. The quantities of various items given in Annexure-A are approximate. The quantities may increase/decrease at the time of allotment and/or execution of work. Bidder will be paid for the actual items/quantities executed at site duly verified by the concerned officials of IIIT Sri City, Chittoor.
8. **Site Visit:** Every bidder is expected to inspect the site/locations between Monday to Saturday from 10:00 Hrs to 16:00 Hrs except Sunday and Govt. holidays, to ascertain the exact requirement of the NIQ, at his own cost before quoting the rates.
9. **IIIT Sri City reserves the right:**
 - a. to accept or reject any or all quotations either in whole or in part or to invite revised price bids or to annul the bidding process
 - b. to postpone and/or extend the date of receipt/opening of quotation or to withdraw the same at any time before finalization without incurring any liability to the affected Tenderer / Bidder.
 - c. to omit/delete any item(s) of work from the schedule at the time of allotment or before the commencement of work without assigning any reason whatsoever.
 - d. to change the quantity or add the item or cancel the item/service required.
 - e. to accept or reject any or all the Tenders without assigning any reason.
10. If the date of opening of the quotation is declared as holiday, it will be opened on the next working at the same time.
11. **Bid Evaluation:** The bid should be submitted strictly in the prescribed 'Annexure A' and should remain valid for a minimum of TWO (2) months.
 - a. The bidder should have at least 3 years of experience of having successfully completed similar works in any University, reputed educational institute, Government Organizations and reputed companies ending last day of receipt of tenders. Without required experience party will not be considered in this tender.

- b. Financial bids, which are incomplete and are not submitted in the prescribed format, will be summarily rejected.
 - c. The Financial bid should clearly contain the details (without erasers/overwriting etc.) as mentioned in the form.
12. The successful bidder needs to arrange for the required material and manpower to the locations at his own cost as per the scope of the work.
 13. The successful bidder has to ensure the safety of the manpower/vehicles deployed in the premises. IIIT Sri City will not be responsible for any incident arising during execution of the work.
 14. **Earnest Money Deposit:** The Earnest Money Deposit amounting to Rs.4000/- (Rupees Four Thousand Only) must deposit through RTGS/NEFT to IIIT Sri city Chittoor Opex Account (A/c. No. 38329375681, IFSC Code. SBIN0016527, (16527)-Sri City (Mallavaripalem),115, Peepul Boulevard Sri City, Chittoor.
 15. **PAYMENT TERMS:**
 - a. 100% of Bill Value for the works shall be made after completion of work within 30 days with applicable tax deductions.
 - b. Payment will be initiated only after receipt of certificate from the official concerned from IIIT Sri City Chittoor.
 - c. All taxes must be clearly mentioned in financial bid.
 - d. No escalation of prices for services will be entertained later in any case.
 16. **TAXES AND DUTIES:** The Rates unless otherwise specified, will be deemed to exclude sales tax or GST or any other taxes and duties, which are in force or may be levied by the Central/State/Local Governments from time to time, on the production and sale of the goods.
 17. On account of security consideration, some restrictions may be imposed by the security staff on the working and/ movement of men and materials etc. The contractor will be bound to follow all such restrictions/ instructions and he shall organize his work accordingly. No claim on this account, whatsoever, shall be payable.

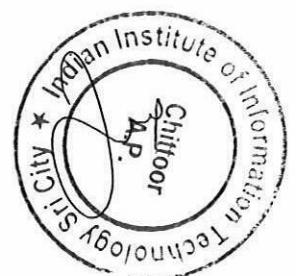
