- The quantities of various items of work given in the Scope of Work are approximate. The quantities of work may vary at time of allotment/execution of work. The Competent Authority of IIIT Sri City, Chittoor reserves the right to omit/delete any item(s) of work from the schedule at the time of allotment / before the commencement of work without assigning any reason whatsoever. Bidder will be paid for the authorized actual work done/items supplied at the site duly verified by the concerned officials of IIIT Sri City, Chittoor The quotation may be submitted only if you are able to supply the material within four days from the date of issue of Purchase Order. Exact delivery period will be mentioned in the Purchase Order.

- The materials are to be supplied on door delivery basis at Registrar Office, IIIT Sri City, Chittoor.
- The Railway Receipt/Public WayBill/Consignment Note along with the relevant bill and challan in triplicate should be dispatched to Registrar Office, IIIT Sri City, and Chittoor immediately on completion of dispatch. If these documents do not reach the Registrar Office, IIIT Sri City, Chittoor in time all wharf age/demurrage incurred, if any, will be recoverable from the bidder.
- As the firm is required to deliver the items at Registrar Office, IIIT Sri City, Chittoor, so the rates must be quoted as F.O.R. destination i.e., IIIT Sri City, Chittoor, 630, Gnan Marg, Sri City, Tirupati Dt A.P-517646 and the rates must include the charges for packing, forwarding, insurance, freight, commissioning, demonstration, transportation charges etc., if any.
- The price of items may be quoted in Indian rupees.
- All the firms may invariably mention their CST/ST/LST/PAN numbers on quotation/tender failing which quotations may not be considered valid. Further, this institution does not issue any Concessional form, so the CST/ST/GST applicable as per actual rates must be mentioned in the offer. - 100% payment shall be made in full within 30 days after receipt of material in good condition. Payment will be initiated only after the receipt of a certificate/report about successful demonstration/installation from the department/officer concerned.
