We congratulate you for securing admission to BTech programme in IIIT Sri City through JoSAA 2023 counseling. You are required to go through the JoSAA website carefully about the Verification center and complete all the formalities.

The candidates who have frozen the seat in IIIT Sri City through in JoSAA 2023 are required to complete the following steps:

STEP1:

As per the information available on <https://josaa.nic.in/> “ All candidates having a provisionally allocated seat in the NIT+ system and having paid Seat Acceptance Fee (SAF) are also required to pay the Partial Admission Fee (PAF) online from their JoSAA portal during 29 July – 1 August 2023 (5:00pm). Non-payment of the PAF within the stipulated time will lead to cancellation of the allocated seat.” Please refer Importance Notice dated 29 July, 2023 “ONLINE Payment of Partial Admission Fee (PAF) for NIT+ System only” for further details on <https://josaa.nic.in/>

STEP2:

Here are the details on the **further process to be followed** by the candidates **who have already paid the partial admission fee and received the provisional admission letter** from JoSAA 2023 by 1st Aug. 2023, 11:59pm in the respective disciplines of our institute for the completion of the admission process for the academic year 2023-2024. Kindly read the document carefully and follow the steps to complete the admission process.

In case if you are participating in CSAB special rounds, please complete the formalities as per the CSAB guidelines given in CSAB website. If you are still allotted IIIT Sri City in CSAB special rounds, then you will receive separate communication about the procedure to be followed for the completion of the admission process (PI reporting) by email and also check our institute website from time to time for further information.

If you are not willing to participate in CSAB special rounds you may please follow the following steps and complete the process as described below.

A. Further Steps to be followed to towards the admission process:

1. Fee payment related: Candidates who have paid the partial admission fee to JoSAA are required to pay the balance Fee Rs.155,000 (Gen, Gen-EWS, OBC-NCL) OR Rs.195,000 (SC, ST, PwD) to IIIT Sri City through SB Collect (details are given in the Annexure A)

2. After the completion of remaining balance fee payment to IIIT Sri City, you need to upload the required documents (list of documents is provided in Appendix B) for verification using the following link: <https://forms.gle/V1JUveqG6wPLaznr7>
3. The documents uploaded by the candidates will be **verified in online mode only** during 14 Aug 2023 (Mon) (10:00 hrs) to 21 Aug 2023 (Mon) (17:00 hrs), also the admission confirmation letter from IIIT Sri City will be sent on a first come first serve basis.
4. A separate communication will be sent regarding class work at the earliest. Till then You are advised **not to plan** for travel to Sri City until you receive communication from the institute.
5. Submission of mandatory Anti-ragging affidavits (Online link will be shared to the candidates after completion of admission formalities).

B. Payment of Balance Fees to IIIT Sri City (Institute fee, **Hostel Fee, Mess Fee, Admission Fee, Caution Deposit and Medical facility at campus and Accidental Insurance**):

The detailed fee structure is given in **Table I.**
(Fee is applicable for all category of students)

Please refer to table II for the amount to be paid to IIIT Sri City. The balance amount, to be paid to IIIT Sri City, through SB collect (SBI) only.

Tuition Fee, Admission fee, Caution Deposit, Hostel Fee and Medical facility at campus and Accidental Insurance:	
Fee Structure: AY 2023-24, Semester 1: through JoSAA/CSAB	
1. One –Time payment	
a) Admission Fee	Rs. 15,000/- (non-refundable)
d) Caution Deposit	Rs. 15,000/- (Refundable at the end of the program)
2. Per semester fee payable at the beginning of each semester	
a) Tuition Fee	Rs. 1,55,000/- per semester
b) Hostel Establishment Fee	Rs. 20,000/- per semester
C) Mess Fee	Rs. 20,000/- per semester
3) Per year payable at the beginning of Monsoon semester	
Medical facility at campus and Accidental Insurance	Rs. 2,000/- per year.

Note:

- 1) Please note that Fee (Tuition Fee, Hostel Fee, Mess Fee and Medical facility at campus and Accidental Insurance) revisions are applicable from 2nd year onwards.
- 2) Please note that All students are required to pay the complete semester Fee before beginning of each semester as per the fee structure/circular
- 3) Please note that there is no fee waiver for SC/ST students.

i) Caste certificate (SC/ST/OBC-NCL) issued by Maharashtra State must be validated by Social Welfare department (in case of SC and OBC-NCL category) and Tribal Welfare department (in case of ST category) of Maharashtra Government. The SC/ST/OBC-NCL candidates of Maharashtra State have to produce their caste validity certificate in the format available on JoSAA 2023 website.
(ii) ST certificates from Tamil Nadu state must be issued by the concerned Revenue Divisional Officer

16. Medical Certificate (in specified Format available on JoSAA 2023 format, Annexure 7)
