- 2. The quotation may be submitted only if you are able to complete the supply and installation within the time limit.
- 3. The materials are to be supplied on door delivery basis at IIIT Sri City, Chittoor.
- The sealed quotation shall be sent to The Registrar, Indian Institute of Information Technology, Sri City, #630, Gnan Marg, Satyavedu Mandal, Tirupati District – 517 646, Andhra Pradesh
- 5. The sealed quotation shall bear the name of work, reference no. and last date of submission written on the envelope
- 6. Last date and time of submission of quotation: 16th Oct, 2023 @ 4pm
- 7. Date and time of Opening: 16th Oct, 2023 @4.30pm
- 8. Validity: Minimum validity of the quotation must be 15 days from the date of opening of the quotation/tenders.
- 9. As the firm is required to deliver the items at IIIT Sri City, Chittoor with minimum one year guarantee/warranty, so the rates must be quoted as F.O.R. destination i.e., IIIT, Sri City, Chittoor, Tirupati Dt A.P-517646 and the rates must include the charges for packing, forwarding, insurance, freight, commissioning, demonstration, transportation charges etc., if any.
- 10. The price of items may be quoted in Indian rupees.
- 11. All the firms may invariably mention their GST/ST/LST/PAN numbers on quotation/tender failing which quotations may not be considered valid. Further, this institution does not issue any Concessional form, so the GST/ST/VAT applicable as per actual rates must be mentioned in the offer. In case GST/ST/VAT is not mentioned, the rates shall be treated as inclusive of all taxes.

- 12. 100% payment shall be made in full within 30 days after receipt of material in good condition.
- 13. Payment will be initiated only after the receipt of a certificate/report about successful demonstration/installation from the department/officer concerned.
