Site Visit: Before submitting sealed quotation as mentioned in the NIQ document, every bidder is advised to inspect the site/locations of work and its environments between Monday to Saturday from 10:00 Hrs to 16:00 Hrs except Sunday and Govt. holidays, to ascertain the exact requirement of the NIQ, at his own cost.
- 8. Scope of Work: Supplying, providing and fixing membrane tensile roof entrance canopy at ACADEMIC BLOCK at IIIT sri city, chittoor.
- 9. IIIT Sri City reserves the right:
 - a. To accept or reject any or all quotations either in whole or in part or to invite revised price bids or to annul the bidding process

11. The quotation should be submitted strictly in the prescribed 'Annexure A' and should remain valid for a minimum of THREE (3) months.

The bidder should have experience of having successfully completed similar works in any University, reputed educational institute, Government Organizations and reputed companies and similar works means previous experience in such membrane tensile roof works for canopy, car parking, roof etc., and also building civil works also acceptable.

- a. Documentary evidences for work experience, turnover, GST, PAN all as indicated & required in the NIQ document should be furnished
- b. The quotation, which are incomplete and are not submitted in the prescribed format, will be summarily rejected.
- c. The quotation should clearly contain the details (without erasers/overwriting etc.) as mentioned in the form.
- 12. The works shall be carried out in the area specified as per the directions of Engineer In-Charge, Safety procedure, specifications and standard code of practice.
- 13. Works shall be awarded to L1 tenderer on L1 quoted rates. Price quoted by tenderer shall be fixed and not subject to any escalation whatsoever during the period of execution of the contract including the extended period, if any.
- 14. This tender notice (NIQ) shall be deemed to form an integral part of the contract to be entered into for this work.
- 15. The successful bidder needs to arrange for the required materials, tools & plants, transportation of materials to site, scaffolding arrangements required for work, trained technicians for the work etc., to the locations at his own cost as per the scope of the work.
- 16. The successful bidder has to ensure the safety of the manpower/vehicles deployed in the premises. IIIT Sri City will not be responsible for any incident arising during execution of the work.
- 17. Water for works shall be provided by IIIT.
- 18. Accommodation and Transportation should be arranged by contractor themselves.
- 19. Quantities are Re-measurable.
- 20. Guarantee / warranty provided by the tensile membrane manufacturer should be in the name of IIIT Sri city,

21. PAYMENT TERMS:

- a) 95% of Bill Value for the works shall be made after completion of work within 30 days with applicable tax deductions.
- b) Balance 5% will be paid after completion of maintenance period of 6 months.
- e) Payment will be initiated only after receipt of certificate from the official concerned from IIIT Sri City Chittoor.
- d) All taxes must be clearly mentioned in financial bid.
- e) No escalation of prices for services will be entertained later in any case
