6. **Completion Time:** All the specified works shall be completed **within 30 days** of award of work including sample approvals.

- The bidder should have experience of having successfully completed similar works or entire civil construction works in any University, reputed educational institute, Government Organizations and reputed companies during last 3 financial years ending 31<sup>st</sup> March of the previous financial year.
  - Similar works means Civil construction works or Building PHE works etc., Irrelevant works like House Keeping, Sewage Cleaning, Sweeping, Boring, Fabrication, Erection et., shall not be considered in similar works category.
  - Documentary evidences for work experience, turnover, GST, PAN all as indicated & required in the NIQ document should be furnished
  - The quotation, which are incomplete and are not submitted in the prescribed format, will be summarily rejected.
  - The quotation should clearly contain the details (without erasers/overwriting etc.) as mentioned in the form.
12. The works shall be carried out in the area specified as per the directions of Engineer In-Charge, Safety procedure, specifications and standard code of practice.
13. Works shall be awarded to L1 tenderer on L1 quoted rates. Price quoted by tenderer shall be fixed and not subject to any escalation whatsoever during the period of execution of the contract including the extended period, if any.
14. This tender notice shall be deemed to form an integral part of the contract to be entered into for this work.
15. The successful bidder needs to arrange for the required materials, tools & plants, transportation including and manpower etc to the locations at his own cost as per the scope of the work.
