Item No. FC9/RF1:

Ratification of the FC for fixation of Pay to Col. T. Umasankar Retd., Registrar

Item No. FC9/RF2:

Progress of construction of two Hostel blocks and one dining hall by M/s NJR Constructions:

IIIT Sri City called for tenders through Notice Inviting Tender (NIT) for "Construction of Hostel III &IV and Dining Hall (RCC Framed Structure) including Civil, PHE, Electrical & Fire Fighting Works" during Feb 2020. L1 was identified as M/s NJR Constructions ltd, Hyderabad. Contract time period: 08 Months. The value of the contract was Rs. 23,52,93,962.70. Due to Covid and lockdown, on Contractor's request, the LOA for the said work was issued on 30.12.2020 vide LOA No. IIITS/Works/20201202, Dt. 30.12. 2020. M/s CUBE was engaged in Mar 2021, to act as PMC, on behalf of IIIT Sri City.

Status of Work as on 31 December 2022

Overall Physical Progress ~ 36% - Financial progress ~ 27.22%

The status of Work as on 15 Mar 2023:

Overall Physical Progress ~ 48%, Financial progress ~ 37.4% (Rs 8,79,98,601.31/-).
