PART A: NIT DETAILS

- 1. IIIT Sri City invites online tenders in single cover system from the eligible / resourceful agencies:
- 2. Tender Documents: The interested parties may download the tender document from websites https://etenders.gov.in/eprocure/app and https://www.iiits.ac.in/tenders
- 3. Bidders are advised to visit the website frequently to find any addendum, corrigendum issued, extension of due date for submission, etc. No separate intimation will be issued or advertised in this regard.
- 4. You are requested to go through the terms and conditions carefully and also visit / inspect the site to familiarize and submit your tender as per procedure explained in the tender document.
- 5. The tenderer(s) if required, may submit queries, if any, through E-mail to tenders.2024@iiits.in to seek clarifications within 17:00 Hrs on 06.09.2024. IIIT Sri City will reply only those queries which are essentially required for the submission of bids.
- 6. IIIT Sri City will not reply the queries which are not considered fit like replies of which can be implied /found in the NIT/ Tender Documents or which are not relevant or in contravention to NIT/Tender Documents or queries received after stipulated, extension of time for opening of technical bids, etc.
- 7. Bids will be open on the scheduled dates. Requests for extension of opening of Bids will not be entertained.
- 10. **Site Visit:** Before tendering, every bidder is advised to inspect the site/locations of work and its environments between Monday to Saturday from 10:00 Hrs to 16:00 Hrs. except Sunday and Govt. holidays, to ascertain the exact requirement of the NIT, at his own cost.

11. Scope of Work:

- 1. Grading, levelling of the earth in open area of the IIIT Sri City.
- 2. Shifting of surplus earth from one location to other.
- 3. No collateral damage while performing the work will be accepted and any loss should be made good with, in monetary terms or fulfilling the loss, but purely at the discretion of the institute. The contractor has no say in this.
- 4. The work hour starts at the given location of performing the job and ends at that location only.

12. IIIT Sri City reserves the right:

- To accept or reject any or all quotations either in whole or in part or to invite revised price bids or to annul the bidding process
- b. To postpone and/or extend the date of receipt/opening of quotation or to withdraw the same at any time before finalization without incurring any liability to the affected Tenderer / Bidder.



- c. To omit/delete any item(s) of work from the schedule at the time of allotment or before the commencement of work or during the execution of work without assigning any reason whatsoever.
- d. To change the quantity or add the item or cancel the item/service required.
- e. To accept or reject any or all the Tenders without assigning any reason.
- 13. If the date of opening of the bid is declared as holiday, it will be opened on the next working day at the same time.
- 14. **Bid Evaluation:** The bid should be submitted strictly in the prescribed 'Annexure A' and should remain valid for a minimum of THREE (3) months.
 - a. The bidder should have experience of having successfully executed/completed similar works in any one of the organizations like University, Government Organizations and reputed companies during last 3 financial years ending 31st March of the previous financial year. Without required experience, at least in one of the organizations, the party will not be considered in this tender.
 - b. Similar works means those works of grading, levelling, clearing of earth and shifting of the loose earth soil on Hire basis.
 - c. Average Annual Turnover in the last 3 financial years shall be produced duly supported by certified copies of balance sheets and audit statement by Chartered Accountant.
 - d. Documentary evidences for work experience, turnover, GST, PAN all as indicated & required in the tender document should be furnished without which it will not be taken into account.
 - e. Financial bids, which are incomplete and are not submitted in the prescribed format, will be summarily rejected.
 - f. The Financial bid should clearly contain the details (without erasers/overwriting etc.) as mentioned in the form.
- 15. The works shall be carried out in open area of the IIIT Sri City campus as per the directions of REGISTRAR, IIIT Sri City.
- 16. The quantities shown in the BOQ are approximate only and are liable to variation up to any extent without entitling the contractors to any compensation, provided the total value of the contract does not vary by more than 20% (twenty percent).
- 17. Works shall be awarded to L1 tenderer on L1 quoted rates. Price quoted by tenderer shall be fixed and not subject to any escalation whatsoever during the period of execution of the contract including the extended period, if any.
- 18. This tender notice shall be deemed to form an integral part of the contract to be entered into for this work.
- 19. The successful bidder should own machineries as required and submit a document proof related to ownership of machineries/vehicle
- 20. The successful bidder needs to arrange all safety materials to the locations at his own cost as per the scope of the work.
- 21. The successful bidder has to ensure the safety of the manpower/vehicles deployed in the premises. IIIT Sri City will not be responsible for any incident arising during execution of the work.
- 22. Accommodation and Transportation should be arranged by contractor themselves.

23. PAYMENT TERMS:

- a. 100% of Bill Value for the works shall be made after completion of every month, after applicable tax deductions within 15 days from the date of certification.
- b. Payment will be initiated only on submission of bill with due certification by the concerned authority of IIIT Sri City
- 24. As and when fuel charges (Diesel only) increase by 5%, the rates will increase by 2.5% (eg: As on date the per ltr Diesel charge is Rs 96.83/- When per ltr Diesel charge reaches Rs 102.12 paisa or more, the unit rate quoted will increase by 2.5%).

25. Taxes & Duties- GST Clauses:

- a. Only valid GST registered bidders will be considered for the tender. The GSTIN of the bidder should be clearly mentioned in the offer.
- b. If bidder is exempted from GST registration under any provision of the GST Law, a declaration with due supporting documents should be furnished for considering the offer.
- c. Bidder to quote the applicable taxes like IGST/CGST/SGST/UTGST: Rate of Tax to be quoted as extra in % against the space provided.
- d. Any other taxes & duties not covered anywhere above may be indicated separately.
- 26. The base price of per ltr diesel price will be the price of Diesel on the day of agreement and will be entered in the agreement.
- 27. TAXES AND DUTIES: The Rates unless otherwise specified, will be deemed to exclude sales tax or any other taxes and duties, which are in force or may be levied by the Central/State/Local Governments from time to time, on the production and sale of the goods.
- 28. On account of security consideration, some restrictions may be imposed by the security staff on the working and/ movement of men and materials etc. The contractor will be bound to follow all such restrictions/ instructions and he shall organize his work accordingly. No claim on this account, whatsoever, shall be payable.
- 29. Order will be placed overnight (before 1700hrs previous day, either by email or written order) for reporting for execution of work next day morning. Delay in not reporting for duty will attract penalty of .05% of the contract value per hour. The delay beyond 4 hrs may attract risk purchase at the risk and cost of the contractor.
- 30. **JURISDICTION:** All the disputes arising out of this order shall have exclusive jurisdiction of Tirupati, Andhra Pradesh only.
